CALL TO ORDER

The meeting was called to order by JS at 7:30 p.m.

PUBLIC COMMENT

POLICE, FIRE AND RESCUE

Sgt. Morris presented the June report. Discussed placing "Watch Children" sign on Fairfield Road. Sgt. Morris stated he would notify fellow officers to monitor speed in the area. If warranted would need to contact PennDOT to follow proper procedure for sign placements. Speed sign will be moved closer to the area to collect all data in that area of the road. JS motioned to concur with the Planning Commission on changes to the Zoning Ordinance. BB seconded. The vote was unanimously approved.

JS motioned to place the proposed draft of Zoning Ordinance on the Highland Township website under "News". BB seconded. The vote was unanimously approved.

Resolution 2025-003 was signed appointing Melissa Stitt to the Planning Commission. Resolution 2025-004 was signed making Robin Keller the authorized signer for Pacific Life. Correspondence from Riders of the Round Table was reviewed. Various correspondences were also reviewed.
