She was advised by BOS that the sign collects data to allow police to know when peak times are for speeding and have extra patrols. May need to contact PennDOT.

John has issue with ag preservation allowing solar. He feels solar is not farming. BB said PA state considers solar farming therefore Township has to consider it farming as well. He said he has no problem with personal solar for personal consumption but doesn't like the idea of feeding the grid. He would like to see solar moved to industrial district. He also stated that data centers are another issue since they pull every resource out of the ground.

Ron wants to know who owns enough property for solar. He was frustrated that PC didn't take their recommendations into account. After much research found that the pdf on Highland Township was not the most current draft.
